**Protect your family from lead dust!
Test your child. Test your home.**

Children can get lead in their bodies by swallowing or breathing lead dust. Lead in the body can

- hurt a child's brain, kidneys and nervous system.
- make it hard to learn, pay attention, and behave.

Ask your doctor to test your child for lead at ages 1, 2, 3 and 4.

**Have your home tested by a licensed lead inspector.

Test Your Child.

All children should be tested for lead poisoning at ages 1, 2, 3 and 4.

Ask your doctor to test your child for lead. If your child does not have a primary care physician call:

Test Your Home.

If you have a child under the age of 6 living in your home, call for a free lead inspection:

Know Your Rights.

The Lead Law protects children under 6 years old who live in a home built before 1978. If there is a problem with lead paint in the home, the owner (or landlord) must fix it. A landlord cannot threaten to evict you, raise your rent, or refuse to rent to you because of lead paint. If you have a legal problem related to lead paint discrimination, contact:
